
INSTALLATION RECOMMENDATIONS:


- A 2-pole, 20-amp breaker is required for installation.
- The breaker can either be dedicated to the surge device or shared with another circuit.
- Install the breaker and surge device closest to the incoming line for best results.
- Ensure the leads from the surge device to the breaker are as short as possible.




Product Diagram
