按规范只认可不进行产品检验的产品/The product approved only in term of the rules: 认可后的产品检验由制造厂按本社批准的产品检验计划进行检验,经检验合格后由制造厂签发合格证明,并连同该产品的本社认可证书复印件一并交付用户,制造厂对产品符合公约、法规、本社规范和本社认可的标准规定负责。After approval, product inspection should be carried out by the Manufacturer in accordance with the product inspection scheme approved by the Society. After type approval, if there are changes to the design, materials used or manufacturing method of the product and important components and such changes affect major characteristics and properties of the product, or property indexes of the product are changed and exceed the scope of approval, related drawings and documents are to be examined and approved by the concerned survey office. Where deemed necessary by the survey office, the surveyor to the Society will go to witness relevant tests and conduct inspection and the results should be able to demonstrate compliance with the approval conditions.
