# **Obsolescence plan #001** Remote Operated Circuit Breaker (ROCB) for A-Series Lighting Control Panel

Subject: Obsolesce plan for ROCB

**Distribution:** Sales organization and managers for pricing, customer service, Mebane production, empower release, PSS and technical services

Introduction:

Effective **March 1<sup>st</sup> 2019**, ABB ELSB will discontinue the sale of Remote Operated Circuit Breaker (ROCB) and software for A-Series Lighting Control Panels. The decision comes due to low order volume and the supplier of the controller could not maintain production. The controller is obsoleted, and our solution is outdated compared to competition. Jason Newby, the Global Product Manager will be investigating the need for a replacement with a possible NPI starting no earlier than 2021.
