1. Definitions

All capitalized terms used in these STC shall have the meaning described in the GTC except where the context of these STC require otherwise.

"Ekip Connect software": free monitoring and configuration software for Tmax XT Hi- Touch and Touch (XT2, XT4, XT5, XT7) and Emax 2 Hi-touch and Touch (E1.2, E2.2, E4.2, E6.2) low voltage circuit breakers. The software can be downloaded from https://new.abb.com/low-voltage/products/circuit-breakers/tmax-xt/software. Downloading and installing Ekip Connect software is a prerequisite to enable the Connect Add-on License described in this STC.

"Connect Add-on License": ABB Software license package used to enable advanced functions (see Annex A) on a Tmax XT (XT2, XT4, XT5, XT7) and Emax 2 (E1.2, E2.2, E4.2, E6.2) Touch and Hi-Touch circuit breakers hardware product using the Ekip Connect software.

2. Scope

These STC are applicable to any Connect Add-on License that enables a function in Tmax XT Hi-Touch and Touch (XT2, XT4, XT5, XT7) and Emax 2 Hi-Touch and Touch (E1.2, E2.2, E4.2, E6.2) circuit breakers products using the Ekip Connect software.

3. Product/Service description
